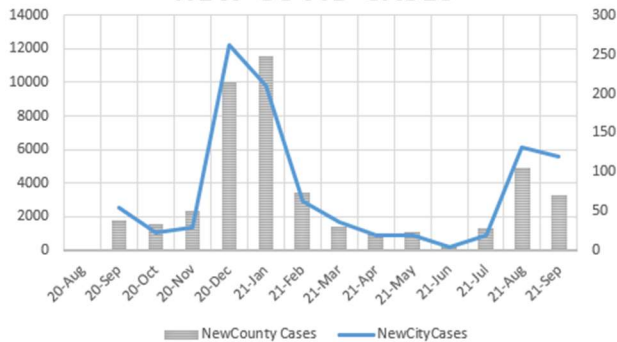


Status of Covid-19

The county's and Foster City's case counts climbed but not by as much as in August. Another 3,277 county residents, including 120 in Foster City tested positive this past month --- continuing at levels not seen since last January and February. Meanwhile, the website "Worldometer" currently records total San Mateo County deaths as 612 – so fatality rates for the disease here have exceeded 1% by some amount. 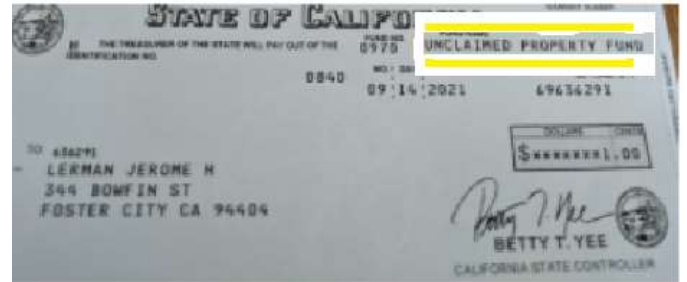
